- 3. Motion by Bedker, seconded by Deanda to replace Jim McKevitt with one of the Summit Township Board member on the Bass Lake Improvement Board. Motion by Chase to nominate Kelly to sit on the LIB as the Summit Township Representative, seconded by Cooper. Ayes: Deanda, Bedker, Cooper and Chase. Abstain: Kelly. Motion carried. Effective today (12/2/2019) the Township Supervisor will hold this position on the Lake Improvement Board. If the Supervisor is unable to perform this duty the Township Board will appoint one of its members to fulfill the position.
- 4. Explanation of the Consent Judgement with Consumers Energy Company that has been reached with Summit Township and various other entities within Mason County.
- 5. Approval to have Ryan's Lawn Care take care of our hall and transfer site's snowplowing and sanding
- for this winter, motion made by Cooper and seconded by Chase. Ayes all, Motion carried.

 6. Motion by Chase, seconded by Cooper to approve a 3% penalty charge on all late payments received between Feb. 15, 2020 and Feb. 29, 2020 for property taxes. Ayes all, Motion carried.
- 7. Motion by Deanda, seconded by Chase to approve a 1% administrative fee on tax bills. Ayes all,

- Motion carried.
- **8.** Motion to extend the Mary Samuel's Deputy Clerk's Position for one more year was made by Deanda, seconded by Bedker. Ayes all, Motion carried.
- 9. Motion to increase clerk's pay made by Chase, seconded by Bedker. Ayes: Kelly, Bedker, Cooper and Chase. Abstain: Deanda. Motion carried.
- 10. Reviewed a proposal to replace Republic Services with Area 31 Recycling & Disposal LLC. This change would keep the cost low as well as getting an "on call" response when needed. Township would still have a contract with Padnos for scrap metal recycling. Motion made by Chase to have the township sign a contract with Area 31 Recycling & Disposal LLC for 3 years starting 2/1/2020, seconded by Cooper. Ayes all, Motion carried.

Treasurer's report: was given with an October 31, 2019 balance of \$595,059.92 disbursement of \$72,359.76, revenues of \$18,730.68 leaving a November 30, 2019 balance of \$541,430.84.

Cooper made a motion to pay the bills, check numbers 10518 to 10555 for \$67,721.36 and Payroll check numbers 15359 15364 for \$4638.40 for a total of \$72,359.76.. Seconded by Chase. Ayes all. Motion carried.
