- 1. Sheriff Report-none
- 2. Fire Chief Report- Total calls for Summit Township in October is 5 and November is 8. The rescue boat will be received by Christmas. The Rural Fire Authority is not wanting to help with funds for fuel, registration or insurance costs. Riverton Township is looking into adding the boat to their insurance. Todd VanNortwick and Mike Cooper will exchange titles and duties with the Riverton Fire Department. Going forward Todd will be the Assistant Chief and Mike will be the Captain. This change comes because of demands from their other jobs. The grant from the Mason County Community Foundation was used to buy thermal imaging cameras for the Riverton firefighters.
- 3. Commissioners Report- Broad Band is still being looked at but now with Lite Community for an open system and Aspen Wireless for a closed system. The ARPA funds are not enough to cover either one of these systems so the cost would have to be voted on by the voters. Council on Aging are looking to hire a part time administrator to oversite several things including getting contracts with the building owners of the locations where the senior centers are located. Fabian Knizachy is looking to retire in the 2023-early 2024 time frame. The Fair Association is looking into getting a Sparks Grant. They will need matching funds and are asking the county to be a type of co-signer for them.
- 4. Road Commission Report- Ride-arounds are going on right now to plan for the 2023-year projects. The Brye Road project that Summit Township has agreed to share the cost with Riverton Township is back on the list for 2023.

Jorissen made a motion to pay the bills totaling \$34,055.09 for check 11280 thru 11319 inclusive and payroll check 15592 thru 15607 totaling \$12,515.42 for a total of \$46,570.51. Seconded by Chase. Ayes all. Motion carried.

**Clerk's Report** – We have received the bills from the August Election and the November Election and they are just below \$250.00 apiece.

**Supervisor's Report** – The gutters on the Summit Park Bathhouse are complete. The generator is installed at the townhall along with the building addition coming along.
